WCCO's Eric Eskola announced the deployment of the Army's 19th Corps Materiel Management Center in New Brighton – Altstatt's Army Reserve unit.

And instantly, for Altstatt and more than 100 other citizen-soldiers in the unit, life turned upside down.

At 7 a.m. Thursday, he and fellow reservists reported to the Twin Cities Army Ammunition Plant in Arden Hills to prepare for active duty, possibly in Bosnia.

Dressed in camouflage fatigues, they entered Building 105, to begin processing for overseas duty. Some seemed excited about their first active duty. Altstatt, a 50-year-old major, tried to remain philosophical.

"You never know what tomorrow will bring," he said.

But Altstatt and the others who won't

be spending Christmas with their families can't help but feel emotional about their call-up.

The reservists leave Monday for Fort Dix, NJ, and as many as nine months of active duty. Right now, it appears they will head to Wiesbaden, Germany, with at least some of them rotating to Bosnia in the coming months.

When he departs, carrying two Armyregulation duffle bags full of cold-weather gear and chemical warfare equipment, Altstatt leaves behind his wife, Marcia, his 86-year-old father, Ray, his business and his home in Excelsior.

Allstatt, who has never been on active duty before, says he knew his unit might be mobilized. Still, he thought the chances minuscule.


After all, there are some 600,000 reservists in this country, and he hadn't been called up in almost 20 years

Mourners across U.S., in France pay tribute to Flight 800 victims

San Diego Union-Tribune, Associated Press - July 22, 1996

In California, 230 white balloons were loosed to the wind, drifting upward as more than 800 mourners below held each other and wept in memory of the victims of TWA Flight 800. At dozens of memorial services dotting the nation yesterday, the living struggled to find peace and, perhaps, understanding. Both were hard.

In Hollywood Hills, where the balloons were let lose, veteran pilot Cliff Waeshle paid tribute in a wavering voice to the pilot of the doomed flight, Ralph G. Kevorkian of Garden Grove. "It just doesn't make a lot of sense at this time, but I'm sure some sense will come of it," said Waeshle, who sported a white ribbon above his gold pilot's wings.

It gave John Talhelm a little comfort to know his sister, Lani Warren (Cross) (pg. 461), 47, was killed doing what she loved most -- flying.

Warren, a flight service manager aboard Flight 800, was a 27-year TWA employee and the wife of San Diego prosecutor Peter J. Cross.

"Lani loved her job and she loved this airline," said Talhelm, who attended the California tribute. "She never wanted to give up flying and the danger didn't bother her."

At Kennedy airport, many relatives standing vigil in a nearby hotel attended ceremonies. The Rev. James Devine celebrated Mass at Our Lady of the Skies chapel at the airport, while Rabbi Alvin Poplack led a service in a garden outside the hotel.

The Crash of TWA Flight 800

Victim recalled as sunny, zestful/ Friends tell of local woman who died on TWA flight: 'She didn't have a mean bone in her body' Lani Warren was on the telephone with a friend Monday, bubbling with excitement as they discussed a party planned for next month. Warren had juggled her schedule as a TWA flight service manager so she could attend.

But the crash Wednesday night of Flight 800 a continent away transformed festive anticipation into numbed bewilderment, and left close acquaintances groping to understand the death of a woman they admired for her zest for life.

"She loved to laugh," said Debbie Sachs, whose voice cracked as she recalled the conversation with Warren. "I'll always remember her laughing and having a twinkle in her eye."

She loved to tell the story about how Woody Allen was on one of her flights and what a character he was. Meeting people was one of the things she really enjoyed about her job."

Warren, 47, was traveling as a passenger from New York to Paris, where she was to work as head of the flight attendants on another plane when TWA Flight 800 exploded shortly after takeoff and plummeted into the ocean. Sachs and several other friends of Warren said they never heard her express any concern abut the risks of her job or the possibility that one of her flights might be the target of terrorism.

Warren's husband, Peter Cross, is a deputy district attorney in San Diego as is Sachs' husband, Richard. Both prosecutors joined the office in 1985, and the couples frequently socialized. Greg Thompson, assistant district attorney in San Diego, said he spoke to Cross Wednesday night. "He's doing well. He's strong. *Article supplied by Kirk Talhelm and Everett Aldstadt*

Sexton plots search for lost families

Finding the descendants of people buried in the more than 100-year old Riverside Cemetery is a tough task. Stacks of photocopies of "Aberdeen Daily News" pages from the late 1800s and early 1900s take up much of the space on two of Kathie Allstot's desks. For the past halfyear, the sexton for the Aberdeenowned Riverside Cemetery and Riverside Memorial Park has been trying to track down heirs of families buried there, starting with obituaries in old newspapers.

"Families have asked if they may purchase the long-abandoned spots to keep their families together," Allstot said. "I've been trying to contact owners of those spots to find out if they're willing to sell."

I. A. Brown purchased 10 graves spaces in 1908, and never used any of them. The family has never contacted the cemetery since then.

There are 165 such spaces in the old Riverside Cemetery, on the south side of Melgaard Road. There's plenty of room in the city's newer Riverside Memorial Park, north of Melgaard, but some people want to keep old-section families together or prefer the

atmosphere in that section, Allstot said. So far, Allstot has tracked down old obituaries that include lists of survivors at the time. Now she's trying to contact descendants of the survivors.

"The cemetery is a beautiful and historic place here in Aberdeen," she said. "Family members with names of people you see our schools and parks named after are here, including Andrew Melgaard, the Simmons family, the Aldriches, Tiffanys and many more."
